

## FAQs PEF Fall Enrichment 2024

### **When are the enrichment classes taking place?**

Classes begin the week of September 9, 2024 and end the week of November 15, 2024. There is a scheduled make up class on Monday, November 18 and Thursday, November 21, 2024.

### **How many enrichment classes are there?**

All classes have 10 sessions except for the electriKIDS classes. electriKIDS dance/workout classes have 7 sessions beginning the week of September 30.

### **Will there be any days that there are not enrichment classes?**

Enrichment classes follow the school calendar and will not be in session if there is no school. Enrichment classes will run unless an instructor is unavailable due to illness. Please look at the dates for your selected enrichment class for additional details.

### **What time does my class start?**

Most classes begin at 3:05 pm if it takes place on an elementary campus. Some classes targeted to younger students begin at 2:40 pm. Please see your confirmation email.

### **Is there supervision for students when they are dismissed from school before the enrichment class starts?**

Yes for 1<sup>st</sup> and 2<sup>nd</sup> grade students only. 1<sup>st</sup> and 2<sup>nd</sup> grade students dismissed at 2:35pm will be supervised by the enrichment instructor before classes begin. Students can have a snack during this time or do schoolwork. If a student is enrolled in Kid's Corner, they would go to Kid's Corner, and then will be brought to the enrichment class when it begins. For students enrolled in Kids Corner, the students are brought back to Kids Corner after class.

TK & Kindergarten students enrolled in enrichment classes will need to be supervised by an adult since they are dismissed earlier. The exception is the Ticket to Ride classes – see below.

The "Ticket to Ride" LEGO classes being offered at Point Vicente & Dapplegray are open to TK & K students and will include supervision by the instructor upon dismissal until the classes begin.

### **What happens if I have a scheduling conflict and need to cancel my registration?**

Full refunds of tuition and fees are granted, less a \$25 processing fee if requested prior to Wednesday, September 4, 2024. No refunds will be granted after September 4, 2024. Email [enrichment@pvpef.org](mailto:enrichment@pvpef.org) to request a refund.

### **My child wants to take a different class than I signed up for. Can I transfer my child to a different class?**

Yes, assuming there is space available. Call or email the PEF office and we will make the transfer for you.

**What happens if there aren't enough students in the class?**

We will determine if a class is viable with enough students by September 3rd. You will be notified about a class cancellation. You can either transfer to another enrichment class, or we will give you a full refund. You will be contacted by email.

**What happens if my student can't attend a class?**

Please email [enrichment@pvpef.org](mailto:enrichment@pvpef.org) to let us know if your student will be absent for an enrichment class. We do not pro-rate tuition for any missed classes.

**How do I reach the instructor during class time?**

If you need to pick up your student early, or if you are going to be late picking up your student, please call the PEF Office at 310-378-2278.

**Can my student only take classes at his/her homeschool?**

No. Students may take classes at any school site. However, we do not provide transportation to or from school sites. Students may not enter campus until school has been dismissed at 3pm.

**Are classes open to all elementary age students?**

Yes. Appropriately aged students do not need to attend PVPUSD schools to attend PEF Enrichment classes.

**TK/ Kindergarten students**

TK & Kindergarten students enrolled in enrichment classes will need to be supervised by an adult since they are dismissed earlier. The exception is the Ticket to Ride (LEGO) classes – see below.

The "Ticket to Ride" LEGO classes being offered at Point Vicente & Dapplegray are open to TK & K students and will include supervision by the instructor upon dismissal until the classes begin.
